COOKIE POLICY

This Cookie Policy is an integral part of the Legal Notice and Privacy Policy of the website <u>www.princesaplaza.com</u> (hereinafter the "**Website**").

In order to make browsing the Website easier, **SELENTA PRINCESA OPERATING COMPANY S.L.U.** (hereinafter **«PRINCESA PLAZA»**), as its owner, with registered office at Calle de Princesa 40, 28008, Madrid hereby informs you that it uses cookies or other data storage and recovery devices with a similar functionality (hereinafter "**cookies**").

In this sense, and in order to guarantee that the user has all the necessary information for correct browsing, we provide the user with the following information on what cookies are, what type of cookies are used on our website and how they can be configured or disabled.

1. WHAT IS A COOKIE?

Cookies are files sent from a web server that obtain information from users' devices, for example, about their preferences and browsing patterns.

Cookies are essential for the functioning of the Internet, as they offer technical solutions that allow the user to navigate through various websites; they cannot damage the user's equipment/device and can be used to identify and resolve possible errors in the functioning of the Website. They may also be used for advertising or analytical purposes.

2. USE OF COOKIES

Specifically, PRINCESA PLAZA uses its own cookies generated directly by this domain and third-party cookies generated from other websites not related to PRINCESA PLAZA, belonging to third parties, for the specific purposes described below. If in the future PRINCESA PLAZA uses other cookies in order to provide more and better services, the user will be informed of this.

(i) Own or required technical cookies.

These allow the user to browse the website and use the different options or services that exist on it, such as, for example, managing traffic and data communication, identifying the session, accessing restricted areas, controlling fraud linked to the security of the service, counting visits for the purposes of billing licences for the software with which the service works (website, platform or application), using security elements during browsing, storing content for the broadcasting of videos or sound or enabling dynamic content (for example, text or image loading animation).

PRINCESA PLAZA does not require your consent to install the cookies that are necessary to activate the functionalities of the Website on your device, and their use is based on the need to provide the services requested. If you disable or block all cookies in your browser, your browsing of the Website may not be optimal and some of the utilities available on the Website may not work properly.

(ii) Personalisation cookies

These are cookies that allow information to be remembered so that the user can access the service with certain features that may differentiate their experience from that of other users, such as, for example, the language, the number of results to be displayed when the user performs a search, the appearance or content of the service depending on the type of browser through which the user accesses the service or the region from which they access the service, etc. If it is the user themselves who choose these features (for example, if they select the language of a website by clicking on the flag icon of the corresponding country), the cookies will be considered as a service expressly requested by the user and will therefore be used exclusively for the selected purpose and without requesting their express consent.

(iii) Analytical or measurement cookies.

Statistical cookies help website owners understand how visitors interact with the website by gathering and providing aggregate information.

The information obtained by these cookies is unlikely to represent a risk to the privacy of users, as they are analysed in aggregate form, for the purposes of obtaining statistics and reports that enable the Website to function better.
